As stated in the current prospectus, the Fund's annual operating expense ratio (gross) is 2.43%. However, the Fund's adviser has agreed to limit its investment advisory fee and reimburse expenses such that total operating expenses (excluding all taxes, interest, portfolio transaction expenses, acquired fund fees and expenses, proxy expenses and extraordinary expenses) do not exceed 1.50%, which is in effect until November 1, 2020, otherwise performance shown would have been lower. Shares redeemed or exchanged within 60 days of purchase will be charged a 1.00% fee.

Average Weighted Market Cap is the average of the market capitalizations of the companies in the portfolio weighted by the size of each company's position within the portfolio. Median Market Cap gives a measure of the size of companies in which a mutual fund invests. Half the companies in the fund have a market capitalization larger than this number, and half have a market cap that is smaller. Trailing Price Earnings Ratio (P/E) is the sum of a company's price-to-earnings, calculated by taking the current stock price and dividing it by the trailing earnings per share for the past 12 months. Price-to-Cash Flow is used to evaluate the price of a company's stock as compared to the amount of cash flow it generates. Price-to-Book Ratio is used to compare a stock's market value to its book value. Book value is the total asset of a company minus total liability.

The FTSE Global Small Cap Ex-US Index is a market-capitalization weighted index representing the performance of small cap stocks in developed and emerging markets excluding the U.S. You cannot invest directly in an index.
