All investing involves risk, including potential loss of principal. **Average Weighted Market Cap** is the average of the market capitalizations of the companies in the portfolio weighted by the size of each company's position within the portfolio. **Median Market Cap** gives a measure of the size of companies in which a mutual fund invests. Half the companies in the fund have a market capitalization larger than this number, and half have a market cap that is smaller. **Trailing Price Earnings Ratio** (P/E) is the sum of a company's price-to-earnings, calculated by taking the current stock price and dividing it by the trailing earnings per share for the past 12 months. **Price-to-Cash Flow** is used to evaluate the price of a company's stock as compared to the amount of cash flow it generates. **Price-to-Book Ratio** is used to compare a stock's market value to its book value. Book value is the total asset of a company minus total liability.

The Russell[®] Microcap Index measures the performance of the microcap segment of the U.S. equity market. Microcap stocks make up less than 3% of the U.S. equity market (by market cap) and consist of the smallest 1,000 securities in the small-cap Russell 2000[®] Index, plus the next smallest eligible securities by market cap. You cannot invest directly in an index.
